The bidders security shall be in the amount of 5% of the highest amount of the bid as guarantee that the Bidder will furnish a 100% Performance and Payment Bond and will enter into a contract with the Owner in accordance with the provisions of this notice and the Contact Documents, and required by law and shall be in the form of a cashier's check or a certified check drawn on an FDIC insured bank in Iowa or on an FDIC insured back charted under the laws of the United States; or a certified share draft drawn on a credit union in Iowa or charted under the laws of the United States; or a bid bond on the form provided in the contract documents with corporate surety satisfactory to the Jurisdiction. The bid shall contain no condition except as provided in the specifications.

Bid Security shall be made payable to City of Carroll, Carroll, Iowa. Bid Security of two lowest Bidders will be retained until contract has been awarded and executed, but no longer than 60 days. No Bidder may withdraw his bid within 60 days after opening of bids.

The City of Carroll, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42U.S.C 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-assisted programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to the invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

Monthly estimates will be paid to the Contractor as the work progresses in amounts equal to ninety five percent (95%) of the Contract value of the work completed during the preceding calendar month. Including the actual cost (exclusive of overhead or profit to the Contractor) of materials and equipment of a permanent nature to be incorporated in the work and delivered to and stored at the job site. Such monthly payments shall in no way be construed as an act of acceptance for any part of the work, partially or totally completed. Final payment, constituting the entire unpaid balance of the Contract Sum, less 5%, shall be paid by the Owner to the Contractor when the Work has been fully completed, the Contract fully performed, and a final Certificate for Payment has been issued by the Architect. Said 5% retainage will be held by the Owner for thirty days and then paid to Contractor upon receipt of satisfactory evidence that all claims pertaining to this contract have been paid in full as provided in the Contract Documents.

Payment to the Contractor will be made by the City of Carroll from cash on hand and/or from cash from such funds of said City as may be legally used for said purposes, or a combination thereof.

The Work under the Contract shall commence on a date to be specified by the Notice-to-Proceed from the Owner to the General Contractor to begin Work, and to substantially complete the entire Project before November 15, 2021.

The City of Carroll, hereafter referred to as the Owner, reserves the right to reject any or all bids and waive any or

all formalities in connection therewith. This notice is hereby given by authority of the City of Carroll, Carroll, Iowa.
