Engagement of Ahlers & Cooney, P.C.

An engagement letter related to a Petition for Declaratory Ruling/Relief and Request for Temporary and Permanent Injunction Relief filed in connection with the Library/City Hall project has been requested and received from Ahlers & Cooney, P.C. The case was filed in the Iowa District Court for Carroll County against Michel J. Pogge-Weaver, City of Carroll, Iowa and City Council of the City of Carroll, Iowa. A copy of the engagement letter is attached.

The engagement letter provides for the following:

1. The City of Carroll agrees to hire Ahlers & Cooney P.C. to defend the City and Mr. Pogge-Weaver again the lawsuit filed by Richard W. Collison.
2. The parties agree that Ahlers & Cooney, P.C. will supply the services of Jim Wainwright and Jason Craig for the purposes of counsel in this matter.
3. Ahlers & Cooney, P.C. will bill monthly for services at the hourly rate of \$290.00 per hour for Mr. Wainwright's services, \$260.00 per hour for Mr. Craig's services, other associate fees at a rate of \$190.00 - \$220.00 per hour and legal assistant time at \$125.00 per hour plus any out-of-pocket expenses.

**RECOMMENDATION:** Mayor and City Council consideration and passage and approval of the Resolution Accepting the Engagement Letter from Ahlers & Cooney, P.C. for legal defense services relating to a petition filed in connection with the Library/City Hall Project.

This letter is to confirm that the City of Carroll ("the City") has retained Ahlers & Cooney, P.C. with respect to the lawsuit filed by Richard W. Collison, DVM in the Iowa District Court for Carroll County. It is our practice to submit for your review this letter of engagement. This letter defines the scope of work we are undertaking on your behalf and sets out the usual policies and procedures of the firm.

All out-of-pocket expenses including, but not limited to, photocopies, filing fees, mileage, etc. will also be separately itemized and billed on our monthly statements. We reserve the right to forward significant expenses directly to you for payment, if any such charges should arise.


