

## Library Board Minutes

August 16, 2021

The Carroll Board of Trustees met in the Community Meeting Room at the Carroll Public Library. Trustees present: Marcie Hircock, Brenda Hogue, Thomas Parrish, Summer Parrott, Julie Perkins, Dale Schmidt, Kyle Ulveling, Ralph von Qualen, and Director Rachel Van Erdewyk. Trustee absent: Lisa Auen.

Parrott called the meeting to order at 5:15. It was moved by Ulveling and seconded by Schmidt to approve the agenda. All voted aye. Absent: Auen. It was moved by Parrish and seconded by von Qualen to approve the minutes of the June meeting. All voted aye. Absent: Auen. It was moved by Hogue and seconded by Perkins to approve the July bills. Director's report: Children's programming continued with Miss Diane's daily Facebook live, drop offs to local daycares and her virtual Rookies at Home with Grab and Go craft pickups. She continued in-person story times with local daycares, Kuemper Cares, and Summer Fun Camp. Adult programs continued with Crafty Library Ladies, Poetry Group, Book Clubs, and Miss Diane's senior book drop offs. In June, a STEM Camp was held with ISU Extension. Anjanette Treadway directed 4<sup>th</sup>-6<sup>th</sup> graders in STEM related activities. Total program attendance was 5,116. Monthly door count was 4,691. Total resources utilized was 45,746. In July Maker Mondays was a hit. Every Monday different projects could be enjoyed and completed in the Makerspace Room. It was come and go and stayed busy until 6:00 every Monday night. For July, total program attendance was 3,454. Monthly door count was 4,510. Total resources utilized was 38,426.
